Sir,

I am directed to refer to your application for grant of Recognition of MBBS degree (150 seats), awarded by Rajiv Gandhi University of Health Sciences, Karnataka in respect of the students being trained at East Point College of Medical Sciences & Research Centre, Bangalore and to say that your college was assessed by the Assessors appointed by MARB to conduct virtual assessment during the final MBBS practical Examination on 25th Feb, 2023. The report of physical assessment is not available with UGMEB.


2. The above assessment report along with the data available on AEBAS and HMIS including CCTV footage was considered in Under Graduate Medical Education board (UGMEB) and certain deficiencies were noted. The same were communicated to college authority vide UGMEB's letter dated 24.05.2023 for compliance.

3. In response to the above, the Principal, East Point College of Medical Sciences & Research Centre, Bangalore submitted their reply vide letter dated 03.06.2023 with regard to the deficiencies pointed out by UGMEB in its letter dated 24.05.2023. Subsequently, an opportunity of the personnel hearing was also given to the college authorities on 13.06.2023.

4. After hearing the college authorities and careful consideration of the facts and compliance, it has been decided by UGMEB that East Point College of Medical Sciences & Research Centre, Bangalore is granted **one year** Recognition of MBBS qualification in respect of the students admitted in the year 2018-19. However they shall apply afresh for recognition in 2024.

5. Accordingly the approval of the competent authority in UGMEB is hereby conveyed for grant of **RECOGNITION FOR ONE YEAR** for MBBS degree for 150 students, granted by Rajiv Gandhi University of Health Sciences, Karnataka in respect of the students being trained at East Point College of Medical Sciences & Research Centre, Bangalore.
6. However, the college authorities are advised to apply afresh to UGMEB in 2024 for Recognition, at least 6 (six) months prior to the final examination of MBBS Part II (Practical) along with requisite fee i.e. Rs.3.54 lakhs only.

Subject: Recognition of MBBS degree (150 seats) granted by Rajiv Gandhi University of Health Sciences, Karnataka in respect of the students being trained at East Point College of Medical Sciences & Research Centre, Bangalore.

Sir,

I am directed to refer to your application for grant of Recognition of MBBS degree 150 seats, awarded by Rajiv Gandhi University of Health Sciences, Karnataka in respect of the students being trained at East Point College of Medical Sciences & Research Centre, Bangalore and to say that your college was assessed by the Assessors appointed by MARB to conduct virtual assessment during the final MBBS practical Examination on 25th Feb, 2023. The report of physical assessment is not available with UGMEB. However, as per the decision taken in the Commission in its meeting held on 11.04.2023, in case infrastructural assessment as well as examination assessment have been carried out, the application for Recognition should be processed as per the regulation norms. In case only one assessment has been carried out, recognition is to be processed for **only one year** henceforth.

2. Accordingly, your application for grant of Recognition (for one year only) of MBBS degree 150 seats, awarded by Rajiv Gandhi University of Health Sciences, Karnataka in respect of the students being trained at East Point College of Medical Sciences & Research Centre, Bangalore has been considered in Under Graduate Medical Education Board (UGMEB). While evaluating the assessment reports alongwith the AEBAS and HMIS data including CCTV, the following deficiencies have been observed.

A. Subject-wise deficiency in Faculty & Resident doctors on AEBAS:

None of the faculty and Resident Doctors registered under AEBAS have marked their attendance.


B. Other deficiencies:

- i. HMIS showed that cameras are not functioning at least for last two months, when checked on 19th May 2023.
- ii. Department of Physical Medicine and Rehabilitation (PMR) also needs to be established.

3. In view of the above, it has been decided in Under Graduate Medical Education Board that recognition (for one year only) may be granted to the MBBS degree awarded by Rajiv Gandhi University of Health Sciences, Karnataka in respect of the students being trained at East Point College of Medical Sciences & Research Centre, Bangalore, only after rectifying the deficiencies mentioned above. However, your application shall be processed for permanent recognition, after the receipt of both the Assessment Report (Virtual Assessment during the final practical examination to evaluate the standard of examination and physical Assessment Report to verify the facilities available at your medical colleges including the faculties and clinical materials etc.)

4. You are requested to kindly submit your response **within a period of 7** days from the receipt of this letter, failing which it shall be assumed that the college authority has no comment/compliance to be submitted before the UGMEB and decision will be taken accordingly.
